



PRIVACY POLICY & TERMS OF USE

This document is issued by Admirals Basketball Academy, a 501(c)(3) nonprofit organization registered in the State of Texas, USA. It governs the collection, processing, and protection of personal data of users, participants, parents, and coaches interacting with the Academy's programs and website. All data collected through this site is handled in accordance with international data protection standards, including principles inspired by the GDPR (EU) and other applicable privacy frameworks.

I. PRIVACY POLICY

1. Purpose

This policy outlines how the Academy collects, uses, stores, and protects personal data related to its programs, communications, and services. It applies to participants, legal guardians, website visitors, and staff, regardless of nationality.

3. Categories of Data Collected

- Identity data: full name, date of birth, gender
- Contact data: phone, email, home address
- Legal guardian data (for minors): name, phone, email
- Health information: allergies, medical clearance (if required for participation)
- Visual data: photos and videos from events or training
- Technical data: IP address, device type, cookies, visit logs

4. Purposes of Processing

Personal data is processed for the following purposes:

- Registration and participation in sports activities and camps
- Internal communication and logistics
- Emergency and medical safety

- Legal, tax, and accountability obligations
- Promotion of the Academy's activities (with explicit consent)

5. Legal Basis for Processing

- Explicit consent by the data subject or guardian
- Legitimate interest of the Academy
- Legal and contractual obligations

6. Data Retention

Data will be retained for no more than 5 years following the end of participation, unless otherwise required by law.

7. Data Subject Rights

Each data subject has the right to:

- Access their data
- Request corrections or deletion
- Restrict or object to processing
- Request data portability
- File a complaint with a competent supervisory authority

8. Sharing with Third Parties

Personal data will not be sold or shared for commercial purposes. It may be shared only with:

- Government authorities if required by law
- Service providers (e.g., medical or insurance) under confidentiality agreements

9. Use of Images

Photos and videos may only be used for promotional purposes with the individual's (or guardian's) written consent.

10. International Data Storage

All personal data may be stored securely on servers located in the United States. The Academy takes all reasonable and legal steps to ensure appropriate protection and privacy standards are applied.

1. Acceptance

By using the website, users agree to the terms outlined in this document. If you do not agree, please discontinue use.

2. Intellectual Property

All content including text, graphics, media, and logos are the property of the Academy. Reproduction or redistribution without written permission is prohibited.
